## ADVANCING PRIORITIES AND REFLECTING ON THE BUDGET

Last spring, IPE/BC made a <u>submission to the Select Standing Committee on Finance and Government Services</u>, focusing on the following five major areas for consideration in the provincial budget:

- 1. Recognizing that public education is in the public interest and a critical element of our democratic society.
- 2. Focusing funding initiatives to support the most vulnerable students.
- 3. Avoiding a return to austerity to be able to recover from the damage of previous austerity measures.
- 4. Defunding private/independent schools.
- 5. Planning to incorporate remedies for the climate crisis in all areas of public education.

BC's provincial budget was tabled in April and support for quality, inclusive public education and the priorities listed above did not feature as highly as IPE/BC had hoped. We recognize the importance of the government's commitment to funding additional mental health supports over the next three years. However, the pandemic has highlighted many of the existing inequities and inadequacies in public education funding in BC which are in need of greater attention.

School boards are now grappling with their budgets for next year and, in some cases, facing potential cutbacks yet again. Additionally, a number of boards are dealing with the collapse of revenue from international students, a reliance that has deepened inequities between districts and should not take the place of adequate, predictable, stable government funding.

## PRIVATIZING PRIVATE EDUCATION

It's a staggering sum-\$3,592,000,000- the amount of public funding that has been given in subsidies to private schools from 2013/14 to the 2021/22 budgets, less than a decade. Further, between 2001 and 2021, government subsidies to private schools have increased by 127% when adjusted for inflation.

In next year's provincial budget, the increase in private school funding will be 5.3% whereas the increase to public schools will be 4.2%. IPE/BC is firmly of the opinion that these subsidies should be phased out and the funding directed to public schools, where it can be used to help every child reach their full potential.

- -Thanks to the Columbia Institute's Centre for Civic Governance for the opportunity to collaborate on a workshop for the High Ground 2021 conference, March 24-26. IPE/BC Chair, Dr. Dan Laitch, moderated the session, A Vision for Public Education, with panelists Colleen Sturrock, a teacher from Langley School District, Owen Ebose, a student activist, and Jamie Smallwood, a parent activist, who also spoke at the IPE/BC Fellows' Forum this spring.
