# Inclusionary practices in BC schools: Are we making progress? IPE/BC March 6<sup>th</sup> Forum

We asked whether we're making progress on inclusionary practices and heard a very clear "No" from the panelists at our recent forum, Hilary Thompson president of <a href="Inclusion BC">Inclusion BC</a>, Tamara Taggart, president of <a href="Down syndrome BC">Down syndrome BC</a>, and Tracy Humphreys, Executive Director of <a href="BCCPAC">BCCPAC</a> and past-ED of <a href="BCEdAccess">BCEdAccess</a>. They each spoke to the ways in which staffing shortages, underfunding, and lack of access to information, among many other issues, are leading to exclusion and, in some cases, segregation of students with disabilities and diverse needs. We're very grateful to them for sharing their experiences and perspectives with us and to our panel moderator, Patti Bacchus, a member of the IPE/BC Board of Directors.

## Firing of the Greater Victoria School Trustees

There are many pressing issues that the BC government needs to address in our public school system-chronic underfunding, severe staffing shortages, inadequate support for inclusion, overcrowding, to name just a few. Therefore, we were very surprised to see the Minister of Education and Child Care dismiss the elected Greater Victoria School Board as a first priority and equally concerned about the precedent it sets. Prior to the dismissal, we called for the Minister to play a constructive role in facilitating dialogue, especially with Indigenous Nations, and considering the needs and safety of young people in a broader context.
